Per McFarland School Board Policy, Administration recommends approval of the following action items for 2025-2026 Open Enrollment.

The Board considered criteria such as class size limits, pupil-teacher ratios and enrollment projections. The enrollment projections were determined by considering criteria, including, but not limited to, residential housing market information, survival ratios, birthrate data particular for the District's zip code, and a 2% margin of error based on residential move-ins. Furthermore, the Board considered the capacity available at each building/facility.

It is important to note that, because of the absence of neighborhood schools in the District, the District assigns all pupils in each grade to the same school. Accordingly, the District sets space limits based on each Grade Level; not on the basis of class or section size or capacity.
