Trip Date: **June 7, 2018**

DROP OFF: Students should arrive at school by 7:15 AM; buses leave promptly at 7:30 AM.

PICK UP: Buses will be returning to the *high school parking lot* at approximately 6:30 PM.

COST: \$60.00 (**Make checks payable to IMMS.** This amount includes the price of admission to the park and transportation on a Kobussen Busses LTD. bus.)

DUE BY: May 8, 2018

WHAT **TO** BRING:

Bring comfortable walking shoes, a sack lunch or money for lunch, appropriate outerwear suitable for any possible weather, and sunscreen. Students will be able to go to the buses during the designated supervised lunch time. We will go rain or shine!

WHAT **NOT TO** BRING:

Do not bring any expensive items; we will not assume responsibility for anything lost or stolen.

Eligibility Requirements:

The 6th, 7th, and 8th grade staff members view this trip as a privilege, and the eligibility guidelines are consistent with the other end-of-the-quarter Celebration Day activities. **The cut-off date for determining eligibility for the trip is June 1st.** Students will be eligible to attend a trip if, by the June 1st deadline, they have:

1. Passed all of their classes for the fourth quarter (No F's).
2. Earned Conduct and Effort Grades for the fourth quarter above a "U" for Unsatisfactory.
3. Earned a cumulative grade point average above a 1.7.
4. Returned any library and classroom books and paid any fees.

There are no exceptions to the above requirements: As a staff, we will regularly inform students of their academic progress and eligibility status. Please discuss these requirements with your child and help them to qualify for this fun and exciting trip. If your child does not meet the eligibility requirements, he/she will be expected to attend school on this day. The cost of the trip will be refunded.
