***Miller Park Trip/Rockin' Jump***

Please read and returned signed **NO LATER THAN TUESDAY, MAY 8!** Keep in mind that the choice for this trip was made in February and no switching is allowed.

**Eligibility Requirements:**

The unit six, seven, and eight staff members view this trip as a privilege, and the eligibility guidelines are consistent with the other end-of-the-quarter Celebration Day activities. **The cut-off date for determining eligibility for the trip is Friday, June 1.** Students will be eligible to attend a trip if, by the **June 1, 2018** deadline, they have:

- Passed all of their classes for the fourth quarter (No F's).
- Earned Conduct and Effort Grades for the fourth quarter above a "U" for Unsatisfactory.
- Earned a cumulative grade point average above a 1.7.
- Returned any library and classroom books and **paid any fees.**

**There are no exceptions to the above requirements:** As a staff, we will regularly inform students of their academic progress and eligibility status. Please discuss these requirements with your child and help them to qualify for this fun and exciting trip. If your child does not meet the eligibility requirements, he/she will be expected to attend school on this day. The cost of the trip will be refunded.

**Miller Park Tour/Rockin' Jump Information:**

The buses will depart for the trip at approximately **8:25am and return around 2:30pm.** When students return to IMMS they will be given the option of watching a movie in a classroom, play board games, or go outside for an extra recess before being dismissed at the regular 3:34 pm dismissal time. **Students should bring a bag lunch to eat following their time at the Rockin' Jump.** The students will travel to Miller Park for their tour lasting from approximately 10:00am-11:30am, then they will load the buses from Miller Park at 11:35am and travel to Rockin' Jump back in Madison. ***Prior to attending the trip, students and families will need to read, sign, agree to, and return the Rockin' Jump Waiver. This waiver will attached to the permission slip. Both forms must be returned to IMMS. Students will not be able to participate at the Rockin' Jump without the waiver signed and returned.***

**Please Note:** All students are required to stay on Miller Park and Rockin' Jump property. ***Students who choose not do so, will have their parent/guardian contacted to come and pick their child up from either Miller Park or Rockin' Jump.***
